



Management for Alojamento Local – Terms and Conditions

Option 1 - Commission of 10%

- Photographic Session of the Property;
- Promotion and Advertisement of the AL in the most popular Vacation House Websites;
- Reservation Management (Calendars and Customer Service);
- Monitoring and Counseling the Activity (Improvements, Legal Needs);
- Check-in and Check-out (Optional);

*Owner will have to pay the commissions of the respective website in which the reservation was made (from 3% to 15% depending on the website).

Option 2 - Commission of 15 %

- Photographic Session of the Property;
- Promotion and Advertisement of the AL in the most popular Vacation House Websites;
- Reservation Management (Calendars and Customer Service);
- Monitoring and Counseling the Activity (Improvements, Legal Needs);
- Check-in and Check-out (Optional);
- Issuance of Invoices through the Finance Portal, SEF Submission, Model 30 and Monthly IVA of Commissions;

*Owner will **NOT** have to pay the commissions of the respective website in which the reservation was made (we exclude websites with high commissions).

Option 3 - Commission of 25 %

- Photographic Session of the Property;
- Promotion and Advertisement of the AL in the most popular Vacation House Websites;
- Reservation Management (Calendars and Customer Service);
- Monitoring and Counseling the Activity (Improvements, Legal Needs);
- Check-in and Check-out (Optional);
- Issuance of Invoices through the Finance Portal, SEF Submission, Model 30 and Monthly IVA of Commissions;

*Owner will **NOT** have to pay the commissions of the respective website in which the reservation was made.

Option 4 - Commission of 30 %

- Photographic Session of the Property;
- Promotion and Advertisement of the AL in the most popular Vacation House Websites;
- Reservation Management (Calendars and Customer Service);
- Monitoring and Counseling the Activity (Improvements, Legal Needs);
- Check-in and Check-out;
- Cleaning after client checkout included;
 - Cleaning during the stay has an extra cost as per the client's needs;
- Laundry (bed linen, towels, etc ...) has an extra charge ranging from 10€ - 20€ per booking depending on the accommodation;
- Issuance of Invoices through the Finance Portal, SEF Submission, Model 30 and Monthly VAT of Commissions;

* Owner will **NOT** have to pay the commissions of the respective website in which the reservation was made.
